



## **Conditions for Associate Membership of COBCOE**

Associate membership of the Council of British Chambers of Commerce in Europe (“COBCOE”) is open to:

- British Chamber of Commerce operating exclusively within the United Kingdom
- British Chambers of Commerce operating exclusively outside of Europe
- Other representative business organisations which are not eligible for full membership of COBCOE (which is limited to British Chambers of Commerce, or like representative business organisations, operating in Europe outside of the United Kingdom).

Your application will then be processed and, subject to approval of your application, you will receive a letter of confirmation with the relevant invoice enclosed.

- The current annual subscription, payable at the beginning of each year, is Euro 750.
- The first subscription of an Associate Member admitted during the course of a year shall be limited to a proportion of the full year calculated as from commencement of the quarter immediately preceding its election.
